Job Outline

As we prepare to open our doors, we are excited to welcome passionate and caring Early Years Practitioners to join our team at Halimah's Nursery. In this role, you will support the Nursery Manager in helping us achieve our *Mission*.

As an Early Years Practitioner, you will work within the EYFS framework, incorporating our Muslim ethos into daily activities to create a warm, supportive, and engaging environment. You will play an important part in fostering children's development through play, learning, and positive interactions.

Safeguarding Requirement

Halimah's Nursery is committed to safeguarding and promoting the welfare of children and young people. It is a requirement of all staff that they share this commitment and follow the prescribed policy and procedures to continuously promote a culture of safeguarding across the whole organisation.

Main Duties

- To teach children, offering an appropriate level of support alongside stimulating play experiences.
- To provide a learning environment that is free from discrimination where each child is listened to, valued and respected.
- To ensure that children are kept safe and that you understand when to follow child protection procedures.
- Carry out observations to establish children's individual development in addition to their general health and wellbeing needs.

- To be aware of any special educational needs (SEN) or disability a child may have, and work with other staff as appropriate to ensure each child's individual needs are known and met.
- Collaborate with the Nursery Manager to ensure the welfare and safety of all children, acting promptly and appropriately on any child protection concerns in line with safeguarding protocols.
- To help set up for the daily programme and tidy away at the end of the session.

This job description is not an exhaustive list of duties, and the post holder will be required to undertake any other reasonable duties discussed and directed by the Nursery Manager. The post holder is also expected to be flexible and adaptable in their approach to fulfilling their duties.

Person Specification

Essential Criteria:

- A sufficient understanding and use of English.
- Pediatric First Aid Certificate or a willingness to obtain one.
- Previous experience of working with young children.
- Level 2 early years education and childcare qualification or equivalent.
- Willingness to learn and undertake further training.
- An understanding of play-based approaches to children's learning and development.
- Knowledge of the Early Years Foundation Stage (EYFS).

Desirable Criteria:

- Level 3 or above early years education and childcare qualification or degree.
- An understanding of how to incorporate a Muslim Ethos.
